When signed, this contract will serve as a binding agreement between talent, referred to as Charlie Singleton, and Buyer/Promoter referred to as, _____

Buyer/Promoter agrees to pay Charlie Singleton \$ 10.000 (ten thousand dollars) in exchange for his services. The deposit for said performance shall be equal to ½ (**one half**) the performance price (\$5000) and is to be paid to Charlie Singleton by (date) _____, and sent to the address listed below. The remaining balance of (\$5000) is to be paid (**In Cash**), upon Charlie Singleton's arrival, the day of the show or at sound check. Promoter/Buyer also agrees to pay Charlie Singleton the remaining balance rain or shine, regardless of the circumstances surrounding any cancelation of the performance on the day of the show.

Performance length for Charlie Singleton will be _____. Any changes in performance length will be negotiated in good faith. Charlie Singleton agrees to attend any Meet and Greet connected with the performance and also agrees to do any videos or radio spots to help promote the show. Buyer/Promoter agrees to promote talent as "**Charlie Singleton And The Natural Born Thrillers**". Buyer/Promoter is also free to use Charlie Singleton's affiliation with Cameo to help promote the performance.

Buyer/Promoter agrees to provide Sound, Lights, Backline and ground transportation for Charlie Singleton in order to ensure the best possible performance.
